Position Summary:

The primary function of the Director of Clinical Services is to provide robust, visionary clinical leadership across all clinical areas of the Hospital ensuring effective operational management, collaborative models of care and delivery of excellence in patient services.

Reporting to the Chief Executive Officer, this position is a senior executive role within the MHPH leadership team and is required to liaise with the Private Hospital Committee, executive, medical practitioners and the leadership team in relation to operational matters, clinical governance, quality and risk management, patient safety and satisfaction, business development and business continuity.

The Director of Clinical Services is required to provide clinical leadership, workforce planning and support growth through innovation, foresight, role modelling and commercial awareness along with the ability to simultaneously manage day to day clinical operations and think strategically.

Mandatory Requirements:

- Evidence of Professional Registration (AHPRA)
- Satisfactory National Police Check
- Current Working with Children's Check (Employee)
- Immunisation History (Satisfactory Health Declaration)
- Photo Identification (Drivers Licence / Passport)

- The DCS will be directly responsible for leading the hospital clinical teams, fostering strong relationships with Visiting Medical Officers (VMO's) and actively seeking out new growth and expansion opportunities, while ensuring that the business meets its financial and operational objectives;
- The role is responsible for ensuring that the hospital achieves a balance between high
 quality health outcomes and an efficient clinical service that meets all aspects of
 strategic and operational objectives, outlined in the strategic plan;
